**Agenda Item 1: Regular and proper cleaning of Ladies Washrooms**

- The suggestion by the student through the suggestion box was - The ladies' toilets in the college should be cleaned regularly and time to time.
- The committee discussed the importance of maintaining cleanliness and hygiene in Ladies Washrooms.
- It was emphasized that washrooms should be cleaned regularly.
- The housekeeping staff should use proper disinfectants and cleaning materials.

**Resolution:**

Regular cleaning will be carried out at fixed intervals and supervised by the concerned authority.

**Agenda Item 2: To discuss restarting of the vending machine facility in the Ladies Room.**

- The suggestion by the student through the suggestion box was - The vending machine facility in the Ladies Room (L.R.) is currently not functioning; therefore, it should be started again.
- The committee discussed that the vending machine in the Ladies Room is presently not functioning, causing inconvenience to female students and staff.
- The importance of providing sanitary napkin vending facilities for health and hygiene was emphasized.
- It was suggested to inspect the machine to identify technical or maintenance issues.
- The committee recommended repairing or replacing the machine if required and ensuring regular maintenance.

**Resolution:**

It was unanimously resolved to repair and restart the vending machine facility in the Ladies Room at the earliest. The concerned department will be instructed to take necessary action and ensure proper functioning.

**Agenda Item 3: Duty timetable for women staff at Ladies Room**

- Assigned staff members will supervise cleanliness and assist students if required.


